WHEREAS, the Board of Education ("the Board") of Sackets Harbor Central School District ("the District') has conducted a careful review of the condition of the District's facilities, with the assistance of BCA Architects & Engineers ("the Architects"); and WHEREAS, this review has led the Board to conclude that a capital project at this time is appropriate to renovate and improve the District's K-12 Building and the Bus Garage, and that this capital project should be presented to the qualified voters of the District at the Annual District Meeting on May 16, 2017; and WHEREAS, the District may, with voter approval, apply \$1,700,000 in the Capital Reserve Fund, toward the cost of the contemplated Project; NOW, THREFORE, BE IT RESOLVED BY THE BOARD OF THE DISTRICT, AS FOLLOWS:

<u>Section 1</u>. The following proposition shall be presented to the qualified voters of the District at the Annual District Meeting on May 16, 2017.

PROPOSITION NO. 1

Do the qualified voters of the District approve a capital project to provide various capital improvements inside and outside the K-12 Building, including, but not limited to, replacement of the entire heating plant, the elevator, windows in the 1967 and 1992 wings, and other improvements, and certain capital improvements to the Bus Garage, including, but not limited to, a new roof, replacement of deteriorated concrete floors in work bays, and other improvements, at a maximum estimated cost not to exceed \$7,942,406, to take \$1,700,000 from the District's Capital Reserve Fund to offset much of the local share of the cost of this project, and to finance by the issuance of serial bonds a maximum amount not to exceed \$6,242,406 for this project?

Section 2. The proposition shall be printed on the ballot in a shorter version, as follows:

PROPOSITION NO. 2

Do the qualified voters of the District approve a capital project to provide capital improvements inside and outside the K-12 Building and the Bus Garage, at a maximum estimated cost not to exceed \$7,942,406, and to take \$1,700,000 from the Capital Reserve Fund for the Project, and to finance by the issuance of serial bonds a maximum amount not to exceed \$6,242,406?

<u>Section 3</u>. This resolution shall take effect immediately.

XII. Approve a Capital Improvement Project to appear on May 2017 Annual Meeting and Budget Vote not to exceed the amount of \$7,942.406.00, utilizing \$1.7 million from the Capital Reserve.
